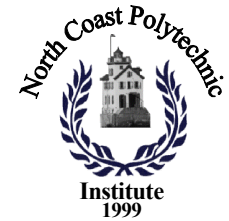

About the Course:

"Evidence and Property Room Management"



This 8 hour program is designed to provide the student with an understanding of the fundamental theories of evidence and property room management. The training includes purpose, role and responsibility of property and evidence controls and a review of the following management requirements: intake, storage, withdrawal, tracking, transfer and return. In addition, bar-coding, software/hardware and special storage considerations for firearms, narcotics, currency and bio-hazards will be discussed. A review of inventory and audit procedures will be provided and methods for disposal and auctions will be discussed. Finally, a brief review of Senate Bill 77 considerations related to DNA will be provided.

ABOUT THE INSTRUCTORS:



Joy Lieb

Ms. Lieb is a career law enforcement officer of 12 years who is currently assigned as a Tax Enforcement Agent with the Ohio Department of Taxation Criminal Enforcement Division (Northeast Region). Her responsibilities within the department include the investigation of misdemeanor and felony tax code violations with a focus upon white collar crime and racketeering influenced corrupt organizations (RICO). She is a member of the FBI's Joint Terrorism Task Force in which she is the Enforcement Division's liaison. Agent Lieb is a certified evidence technician, field training officer and computer forensics examiner. She is currently assisting her agency in designing their own in-house evidence and property management system. Agent Lieb was recognized by the Ohio Attorney General Richard Cordray in 2010 for her role in suppressing a Northeast Ohio auto theft ring in which she assisted in securing convictions of 15 suspects indicted on 51 felony counts, including RICO. Agent Lieb attended Cuyahoga Community College where she focused her studies in the field of accounting and graduated from the school's criminal justice OPOTA Academy. She has also received numerous certifications from the National White Collar Crime Center.

Captain Jack M. Hall, B.S., CLEE, is the Support Operations Captain of Cleveland Metroparks Ranger Department. He is a 21 year experienced law enforcement professional and respected instructor in the law enforcement field – both regionally and nationally. Captain Hall is a graduate of Bowling Green State University and has continued his professional education: graduating from the Police Executive Leadership College (PELC) and attaining the distinction of Certified Law Enforcement Executive (CLEE). He is an instructor with the Basic Police Academy at Polaris Career Center and a former adjunct professor of criminal justice at Lorain County Community College. The captain has received advanced training in homicide investigation, computer forensics and electronic crimes, narcotics investigations and various legal issues. Captain Hall is a member of the faculty advisory committee for Remington College and he maintains his membership as a paralegal with the Ohio State Bar Association.
