# **FIELD TRAINING OFFICER (FTO)**

**Sept 27-30, 2022 Cost: \$360**

*Hosted by Seven Hills Police Dept*

This four (4) day school is designed to provide information and training to the Field Training Officer (FTO) to prepare a probationary officer with the necessary information and tools to properly and professionally begin their career as a peace officer. The FTO is an integral part in assisting the probationary officer to make the transition from the classroom environment to the application of learned skills in field situations. The training program will include information on the role of the FTO, the adult learning concepts, the evaluation process, civil liability issues, coaching and mentoring, ethical leadership, effective communication skills and documentation in the FTO manual. Each student will receive two (2) thorough and detailed comprehensive FTO training manuals (San Jose and LA models) that should serve as a documentation & evaluation tool to successfully promote the development of the probationary officer. Both manuals will also be on a CD ROM that will be provided to each student.

**TOPICS INCLUDE: Role of the FTO; Adult Learning Concepts; Evaluation Process (DOR Review); Civil Liability; Motor Vehicle Operation; Coaching and Mentoring; Ethical Leadership; Effective Communication Skills; Documentation in the FTO Manual; and Motivation and Managing a Diverse Employee Workforce.**

**Instructors: WILLIAM D. HEALY** was a career law enforcement officer for over 29 years. For 24 years Mr. Healy had been a member of the Ohio State Highway Patrol and was the Commander of the Highway Patrol's Traffic Drug Interdiction Team (TDIT). He also served for over five years as a manager/instructor at the Highway Patrol Academy. Mr. Healy has Bachelor's Degree from Ohio University and a Master's Degree from Central Michigan University in General Administration. He is a graduate of Southern Police Institute's Administrative Officer's Course at the University of Louisville. He is currently the Director of the North Coast Polytechnic Institute, a criminal justice training business in North Ridgeville, Ohio.
