The U.S. Supreme Court has rendered three (3) major "Miranda" related decisions in the past 6 months. In essence, the Court held that 1) silence during interrogation does not invoke the right to remain silent, 2) Miranda warnings do not have be verbatim; different words may apply to convey rights to a suspect, and 3) because the suspect experienced a break in Miranda custody for more than two weeks between the 1st and 2nd interrogations, the Edwards rule does not mandate suppression of his statements. For more information on these three (3) cases, please attend a "Legal Updates" seminar.

For your information, I will be conducting a Federal concealed carry firearms qualification for retired law enforcement officers this Fall. The federal concealed carry law supersedes State laws and enables retired officers to carry firearms throughout the U.S. Retired officers must qualify annually equal to the requirements for peace officers in Ohio. I will be using an outdoor range in Litchfield (Medina county off SR 83) to conduct this qualification.

The qualifications will be conducted on August 12th, September 18th and October 27th. Please pass the word on to any retirees through your department to see if they are interested. They should directly contact me to set up a date and to determine the fees involved.

"Glut" of Experienced Leadership
